### What is this form for?

The relevant parts of this form should be completed where Additional Trustee(s) are being added to the discretionary trust deed, and/or a Trustee is to stop acting.

It is made up of two parts:

- PART 1: Discretionary Trust Deed of Appointment of Additional Trustee(s)
- PART 2: Discretionary Trust Deed of Retirement of Additional Trustee(s)

If an appointment is being made and a Trustee is to stop acting, the whole form must be completed.

If your Investment Bond policy is in Trust, Trust Registration Service evidence will be required, if not already provided to us, to reflect the changes you are requesting so we can accurately record them in our records.

# PART 1 – TRUST DEED OF APPOINTMENT OF ADDITIONAL TRUSTEE(S)

## Completion guide

If, after seeking legal advice, no alterations are to be made to this Discretionary Trust Deed of Appointment of Additional Trustee(s), the following sections need to be completed:

### 1. Declaration

You must include:

- The date the Deed is made at the beginning of this section.
- The name(s) and address(es) of the Appointor. The Appointor will be the Settlor/Settlor(s) under the Trust Deed or, in the event that the Settlor/Settlor(s) has/have both died, the existing Trustee(s) of the Trust.
- Where the Settlor/Settlor(s) is/are the Appointor, the name(s) and address(es) of any other existing Trustee(s) of the Trust must be added as Continuing Trustee(s).
- The name and address of each Additional Trustee being appointed. At least one Trustee must be resident in the UK and it is preferable for administrative and taxation purposes that Additional Trustees are also resident in the UK.

### 2. Recital

The date of the Trust Deed, the name of the Settlor/Settlor(s), the name of the Trust and the Bond policy number must be inserted.

### 3. Signatures

The Deed must be signed by the Appointor(s), the Continuing Trustee(s) (if applicable) and the Additional Trustee(s). All the signatures must be witnessed.

### 4. Identity verification certificate

A separate Identity verification certificate must be completed for each Additional Trustee. You can use a photocopy of the page and attach it to this form.

If the Trust is a Passive Non-Financial Foreign Entity, each additional Trustee is required to complete a **Self-Certification - Individual** form.

- The legal ownership of the Policy rests with the Trustees. This Deed of Appointment extends legal ownership of the Policy to the Additional Trustee(s). Such ownership shall be held jointly by the Trustees and the Additional Trustee(s).

### Now this Deed Witnesses as follows:

- The Appointor being duly authorised by the Trust and in pursuance of every other power so enabling him/them hereby appoint(s) the Additional Trustee(s) to be (a) trustee(s) to act jointly with the Trustees for all the purposes of the Trust.
- The Trustees hereby assign the legal and beneficial title in the Policy to themselves and the Additional Trustee(s) jointly so that the Policy shall henceforth be in the legal ownership of the Trustees jointly with the Additional Trustee(s) as trustees of the Trust.
- The Trustees and the Additional Trustee(s) hereby agree to notify Phoenix Life Limited of any changes of trustees under the Trust.

### Data protection
