- the Manager to make such deductions from the Scheme as agreed with me to cover the fees, charges and out-of-pocket expenses arising from the safe keeping, handling and carrying out of transactions in respect of any assets held for the Scheme by the Manager.
- the Scheme Administrator to recover from the Manager such amounts as are necessary to cover the Scheme Administrator's fees and expenses as set out in the Family Suntrust – Terms & conditions.

I understand that:

the Scheme Administrator, the Trustee and the Scheme Provider do not act as investment managers in relation to investments under the Scheme and do not accept any liability for the performance or choice of investments, or performance or choice of the Manager. I promise to be responsible for and pay to the Scheme Administrator, the Trustee and/or the Scheme Provider all reasonable costs, claims, expenses, tax charges, demands and losses whatsoever that the Scheme Administrator, the Trustee or the Scheme Provider may suffer or incur arising from the activities, any failure to act or the performance of the Manager. This Declaration and promise shall be governed by the laws of England and Wales.
